If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0.8000 per one hundred dollars of assessed valuation of real and personal property.

Shall the Board of Education of the Glenwood R-VIII School District, Missouri, borrow money in the amount of Two Million Dollars (\$2,000,000) for the purpose of providing funds to repair or replace roofs; to complete exterior building improvements; to upgrade playground equipment; to complete athletic complex improvements including new bleachers and construction of a new building for concessions and restrooms; to replace heating, ventilation, and air conditioning (HVAC) units; to renovate restrooms; to refinish the gymnasium floor; to increase instructional space by remodeling existing areas; to the extent funds are available, complete other repairs and improvements to the existing facilities of the District; and issue general obligation bonds for the payment thereof resulting in an estimated increase to the debt service property tax levy of \$0.3400 per one hundred dollars of assessed valuation?

If this proposition is approved, the adjusted debt service levy of the School District is estimated to increase from \$0.0000 to \$0.3400 per one hundred dollars of assessed valuation of real and personal property.
